

**Learning Magazine's WIN Giveaways  
Official Rules**

**The *Learning* magazine WIN Giveaway Sweepstakes (“Sweepstakes”) is intended to be played in the United States only and shall only be construed and evaluated according to US law. Entries originating from persons located outside of the United States at the time of entry are void. Do not enter this Sweepstakes if you are not located in the US at the time of entry.**

1. **No purchase necessary. MAKING A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING.** Sweepstakes is open only to legal residents of the 50 United States (except Rhode Island) and District of Columbia who, at the time of entry, are 21 years of age or older, are currently employed either full time or part time in the field of education and are located in the United States. Infobase Holdings, DBA The Education Center, publisher of *Learning* magazine, (“Sponsor”) is the sole sponsor of this Sweepstakes. Employees of the Sponsor and affiliated companies, subsidiaries, distributors, sales representatives, agents, advertising and promotional agencies, and the immediate families and household members (parent, spouse, child, or sibling) of each are not eligible to participate. Sweepstakes Entry Period starts on July 24, 2018, and ends at 11:59:59 pm EDT on September 18, 2018 (“Sweepstakes Entry Period”). All entries must be received by Sponsor by 11:59:59 pm EDT on September 18, 2018. Entrants must follow the entry instructions and provide complete, accurate, and truthful information in all the information fields on the entry form. Entries generated by script, macro, robotic, programmed, or any other automated means are prohibited and will be disqualified. Sponsor is not responsible for lost, late, incomplete, or misdirected entries. Upon receipt, all entries become the property of Sponsors and will not be returned. Receipt of entries will not be acknowledged. Sponsor reserves the right to terminate early, modify, or suspend the Sweepstakes should there be a security breach or other circumstances affecting the fair administration of the Sweepstakes and randomly award the prizes from among all entries received prior to such action taken by Sponsor.
3. **Drawing:** Winners will be selected in a random drawing conducted on or about September 19, 2018, from among all eligible entries received. By participating, entrants agree to abide by and be bound by the Official Rules and by the decisions of the judges, which are final and binding in all matters relating to this Sweepstakes. Entrants are responsible for compliance with all applicable laws. Winners will be notified by email, telephone, or US mail. Odds of winning depend on the number of eligible entries.
4. **Prize:** Prizes are not transferable by winners and no prize substitutions will be allowed, except in Sponsor’s sole discretion due to unavailability of featured prize. If, for any reason, the Internet portion

of the Sweepstakes is not able to run as planned, including but not limited to infection by computer virus or worm, tampering, fraud, technical failure, or any other cause that corrupts or threatens the administration, security, or integrity of the Sweepstakes, the Sponsor reserves the right, in its sole discretion, to discontinue, suspend, or cancel the Sweepstakes or any portion thereof. Winners will be required to execute and return an affidavit of eligibility and liability and publicity release (where permitted) within 14 days of the date on which Sponsor transmits the notification of winning a prize. Failure to do so will result in prize forfeiture, and an alternate winner will be selected from among remaining eligible entries. All taxes on prizes are the responsibility of the winners.
